

I am pleased to present the comprehensive annual report of Pambula Surf Life Saving Club (SLSC) for the 2023/2024 season. As the President of Pambula SLSC, it is my honour to highlight the remarkable achievements and efforts of our dedicated members throughout the year.

Lifesaving Endeavours

The past season has exemplified our club's unwavering commitment to lifesaving and beach safety. Despite facing persistent challenges, our members have demonstrated exceptional dedication in patrolling Pambula each. The implementation of our Flexible Rostering System has not only allowed for increased flexibility but has also revolutionised the way we approach patrol duty. By accommodating the diverse schedules and commitments of our members, this innovative system has created an environment where everyone feels valued and empowered to contribute. As a result, we have witnessed a surge in participation and inclusivity within our patrol teams, strengthening our ability to safeguard Pambula Beach effectively. This success is a testament to the adaptability and dedication of our members, who have embraced this new approach wholeheartedly, further solidifying our 'No Lives Lost' record.

Over the course of the season, our members collectively contributed 2417 hours of voluntary service on patrol duty, resulting in 310 preventative actions and 6 successful aquatic rescues. I extend my heartfelt congratulations to our esteemed Club Captain, Liam O'Neill, and all our diligent Patrol Captains. However, it is essential to acknowledge that the true backbone of our success lies with each and every one of our patrolling members, whose tireless efforts ensure the safety of all beachgoers.

Education Initiatives

Despite challenges, our education team has made significant strides in upskilling our members. This season, we are proud to report that:

- 12 members completed the Bronze Medallion.
- 13 members obtained the Surf Rescue Certificate.
- 16 members acquired the Advanced Resuscitation Techniques (ART) certification.
- 5 members completed the IRB Crew course.
- 2 members became certified IRB Drivers.

These achievements underscore our commitment to equipping our members with the necessary skills and knowledge to excel in lifesaving efforts.

Nippers Program

Our Nippers program continues to be a cornerstone of our club's success, providing invaluable surf survival skills to our youth while fostering a sense of community and camaraderie. I extend my

LIFESAVING REPORT

With immense pride and gratitude, I extend my heartfelt appreciation to the patrolling members of Pambula Surf Life Saving Club (PSLSC) who dedicated their valuable time throughout the 2023/24 season to ensure the safety of both locals and tourists at Pambula Beach.

I would also like to acknowledge the exceptional leadership of my fellow patrol captains—Andrew Holt, Peter Bootes, Emma O'Neill, Frank Davey, Jamie Lynn, Ben Smith, Chris Briggs, David Prowse, Gavin Granger, and Simon Byrne—for their outstanding guidance and the wealth of knowledge shared with their teams. Their hard work and commitment have been instrumental in making this season a resounding success. Furthermore, I extend special thanks to Gavin Granger, whose relentless efforts ensured all IRBs were rescue-ready, and to Miep Krechting, whose exceptional management of our first-aid room made it the best stocked on the Far South Coast.



Patrol Activities and Achievements

Throughout the duration of the patrolling season, running from October 2023 to April 2024, our volunteers admirably fulfilled their duties, completing 2,416.53 hours of patrol. During our patrolled times, we saw over 27,000 visitors to Pambula Beach. Our team conducted six rescues, attended to 23 cases requiring first aid, and performed 310 preventative actions.

This season saw us emerge as leaders within Surf Life Saving New South Wales (SLSNSW) as we implemented a flexible patrol roster. This innovative approach, borrowed from our friends at Bermagui SLSC, allowed members to take ownership of their patrol rosters and make time in their schedules for volunteering. As a club, we welcomed both members who could commit to a full patrol roster and those who could contribute on an ad hoc basis, encouraging member involvement regardless of their level of availability.



As the saying goes, 'many hands make light work.' While some members still went above and beyond, this year saw a more even distribution of the amazing 2,490.53 hours we committed between the flags. A huge thank you goes to our president, Emma O'Neill, for the countless hours of admin work she put in behind the scenes to get this patrol option up and running. Pambula is a club of firsts; while we weren't the pioneers of this innovation, we have established ourselves as leaders in flexibility and have been recognised by SLSNSW for our initiative.



The timing of patrols changed this season as dictated by a new Lifesaving Service Agreement with SLSNSW. Pushing back to a later start time was not seen as most appropriate by many of our members; however, we all adapted well. Based on extensive data analysis conducted by Emma O'Neill, Ben Smith, and myself, a business case for change has been submitted to SLSNSW for the upcoming season. We thank everyone for their flexibility as we negotiate these changes.



Support Operations

A sincere thank you to our club Call Out Team (COT) for responding to numerous emergency call outs this season. Our COT, filled with experienced lifesavers, has been consistently professional and effective in their response. Additionally, thank you to those members who volunteer their time with the Far South Coast Branch Rescue Services Team (formerly the Support Operations Team). We look forward to the installation of two Emergency Response Beacons in our area in the upcoming season, which will fast-track our responses to both the Pambula River Mouth and Merimbula Bar Beach, identified as black spots.

Nippers and Junior Activities

I would like to extend a special thank you to the Nippers Water Safety Team, led by Ben Smith and John Grady, for stepping up and operating independently of the community patrols. Lauren Moreland has been exceptional in her role as Junior Activities Chair, shifting the Nippers culture and actively involving parent helpers. Well done, Team Nippers!



I am immensely proud of the dedication and commitment shown by all members of PSLSC. Your efforts ensure the safety and enjoyment of Pambula Beach for all visitors, and I look forward to another successful season ahead.

Twenty-five years ago, a remarkable journey began—a journey that would touch countless lives, create lasting memories, and foster a sense of belonging.

I am Natasha, a proud parent and a witness to the magic that unfolds within Same Wave. My son, Sam, joined Same Wave at the age of 4 and a half, he is now 19. Picture it: a little guy with autism, squinting at the ocean like it holds the secrets of the universe. Spoiler alert: it actually does!

When we entered the world of Same Wave, we were welcomed with open arms. Same Wave became a lighthouse, embracing us and reminding us that we were not alone.

Over the past 15 years, Sam has learned not only water skills but also the art of resilience. The ocean, with its unpredictable tides, became his classroom—a place where participants discover strength and courage.

Each Saturday, as laughter echoes across the shore, as participants walk hand in hand supported by volunteers, we see the absolute best of humanity in the most beautiful of places- Pambula Beach. Many times, I have stood on the shore and heard Sam's laughter and seen his beaming smile, which often left a quiet tear in my eyes (don't judge me; I'm sure it was just the salty air).

Over the years, countless participants have

Another big season coming up for PSLSC in 2024/25!!


The 2023/24 rowing and paddling season was a little quieter than the previous year but shaping up to be a super busy one for the 2024/25 season at PSLSC.



UAV CAPTAINS REPORT

The UAV Captain would like to express his gratitude and many thanks to all the duty lifeguards & volunteer lifesavers assisting with the UAV beach setup and their support throughout the 2023-2024 season.

I would also like to give a special thanks to all the committee members who have continued their enthusiastic support of UAV operations.

- AUAVS 2023-2024 Season review summary: -
 - The club now has one new UAV, a Mavic 3 Enterprise E & will have a Mavic 3 Enterprise T very soon. The 'E' designates extended optics & the 'T' designates thermal imaging. These are outstanding assets allowing far greater coverage than the drones they replaced. My hope is that UAV pilots & operators are trained in night operations which would make the thermal imaging drone very useful in search & rescue operations.
 - The AUAVS has recently had some management changes. Sol Rainbow is now no longer the FSC AUAVS supervisor. A replacement will be found prior to commencement of the 2024-2025 season. As part of the restructure the AUAVS has disbanded the Location Equipment Officer (LEO) role, which means I am no longer the LEO for Pambula. This role will be operated by the AUAVS FSC supervisor.

Saturday 30th December 2023

This troublesome 2 metre bronze whaler caused the UAV pilot (me), the patrol captain (Gav) and the IRB boat crew some consternation. Whilst traditionally not a dangerous shark, this one however decided to get within 2 metres of some beachgoers who were still in the water & ignoring sirens & shouts to get out of the water.


Fortunately, the IRB crew were able to intervene and shoo it away without it causing harm. This was very uncharacteristic of a bronzy as it seemed to be wounded.



This dark shadow was estimated to be a 3 – 3.5 metre great white sighted at the other end of the beach by the UAV pilot (me) not long after the bronzy was given its marching orders. This photo demonstrates the difficulty in identifying dangerous marine animals in sometimes difficult conditions. It's only through experience that this animal was spotted. Once again, the IRB crew did an excellent job in shooing it out to sea.



Typical patrol day on Pambula Beach during summer 2023-2024




As per previous years as from the end of January there was no UAV patrols except for Nipper's training on Sunday mornings throughout February, March, and April. As per the previous nippers season the UAV Captain volunteered to provide UAV patrols for most of these days.



Nippers Sunday activities

Nippers enjoying something different with their activities on Sunday 18th February. NSW Police vessel was stationed off Pambula Beach for each nippers group to be welcomed aboard and to view this incredible vessel firsthand.





UAV Captain, Mike Doering, providing Uncrewed Aerial Vehicle (UAV) education to our various nipper groups. This session was welcomed by the nippers as they were able to view what the beach & surf

look like from the sky. Basic safety instruction was also conducted demonstrating to the nippers that safety was the most important aspect of being a UAV pilot.

In summary

Generally, the season was thankfully very uneventful, only three shark sightings. Beachgoers were generally friendly and curious. This being my third year flying UAV's (drones) at Pambula Beach many locals & visitors are now very used to the drone being on the beach. Notes to the Financial Statements

Pambula Surf Life Saving Club Incorporated For the year ended 30 June 2024

1. Material Accounting Policy Information

The association was incorporated 4 April 1989 (Y0733922) under the *Associations Incorporation Act 1984*, NSW as a Not For Profit Entity, and these accounts are compliant with this Act. It is registered with the Australian Business Register - Australian Business Number 83 872 472 712. The association is registered for Goods and Services Tax purposes and reports quarterly on a cash basis. Until 4 May 2024, the association conducted fundraising under the Surf Life Saving NSW fundraising authority (CFN11033). After 4 May 2024, the club obtained its own separate authority to fundraise (CFN 26952), which is under the provisions of the Charitable Fundraising Act 1991. This authority remains in force until 3 March 2027.

In the committee members' opinion, the incorporated association is not a reporting entity as there are no users dependent on general purpose financial statements. This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 2009*, the *Associations Incorporation Regulation 2022 (NSW)*, the *Charitable Fundraising Act 1991 (NSW)* and the *Australian Charities and Not-for-profits Commission Act 2012*. The committee has determined that the association is not a reporting entity. The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting interpretations, and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, AASB 124 Related Party Disclosures, Changes in Accounting Estimates and Errors, AASB 1048 Interpretation of Standards and AABS 1054 Australian Additional Disclosures. No new accounting standards were applicable for this accounting period.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Income Tax

The association is income tax exempt under subdivision 50-45 of the *Income Tax Assessment Act, 1997.* Consequently, no provision for taxation has been made in the financial statements.

(b) Fixed Assets

The depreciable amount of all fixed assets are depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use. Donated assets are brought to account at fair value at the date of acquisition.

(c) Inventories

All inventories are stated at the lower of cost and net realisable value. The "First In First Out" method has been used to assign cost to individual items of stock.

Critical Accounting Estimates and Judgements

The committee make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances. These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates. There are no areas that involve a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements other than those described in the accounting policies.

Information & Declarations to be furnished under the Charitable Fundraising Act 1991

During the year the association obtained net income of \$62,736.95 for charitable purposes. Of this income \$17,071.71 was used for fundraising activities. The surplus was used for equipment purchases and maintained. Fundraising efforts conducted included raffles and donations.

Key Management Personnel and Related Party Transactions

The committee and volunteers did not receive any remuneration from the association during the year other than reimbursement of out of pocket expenses that have been fully substantiated. There were no related party transactions with the committee during the financial year.
